COURSE PARTICIPATION

Yoga with Esme's Vinyasa Yoga Teacher Training is a 200-hour curriculum designed to give a well-rounded, balanced education, and involves exploring and discussing various different belief systems. As the participant, I understand that these may differ from my personal beliefs and that the training is not requiring me to change my beliefs but to be respectful of all ideas and practices presented.

The practice of yoga explores and often pushes boundaries and personal limitations that can affect individuals physically, emotionally and psychologically. I understand that each person's level of physical, emotional and psychological fitness is different and that some activities may not be appropriate for me given my individual capability.

I understand that the program instructors and staff are not responsible for managing each individual student's personal needs, and that I am responsible for my experience and well-being during the entirety of the course. I also understand that neither Yoga with Esme nor any of the teachers associated with the course is not responsible for any negative physical, emotional or psychological outcomes from me choosing to participate in exercises.

Although my attendance is mandatory to become certified as a vinyasa yoga teacher, I understand that my participation is not required should I feel unsafe in any way. I understand that it is my responsibility to honour my physical, emotional and psychological boundaries, and that if I feel unsafe in any way, it is my responsibility to stop and speak to a member of staff.

SUBSTANCE USE

I understand that the use of alcohol or other recreational drugs is prohibited during Vinyasa YTT hours as well as on the premises where the course takes place. I accept that the violation of this policy at any time during my participation in the course will result in immediate dismissal from the program and that I will not receive a refund.

MULTIMEDIA RELEASE

I understand that photographs, videos and audio recordings will be taken throughout the course for promotional purposes.
